
APPELLANT'S MOTION TO DENY SHOW CAUSE



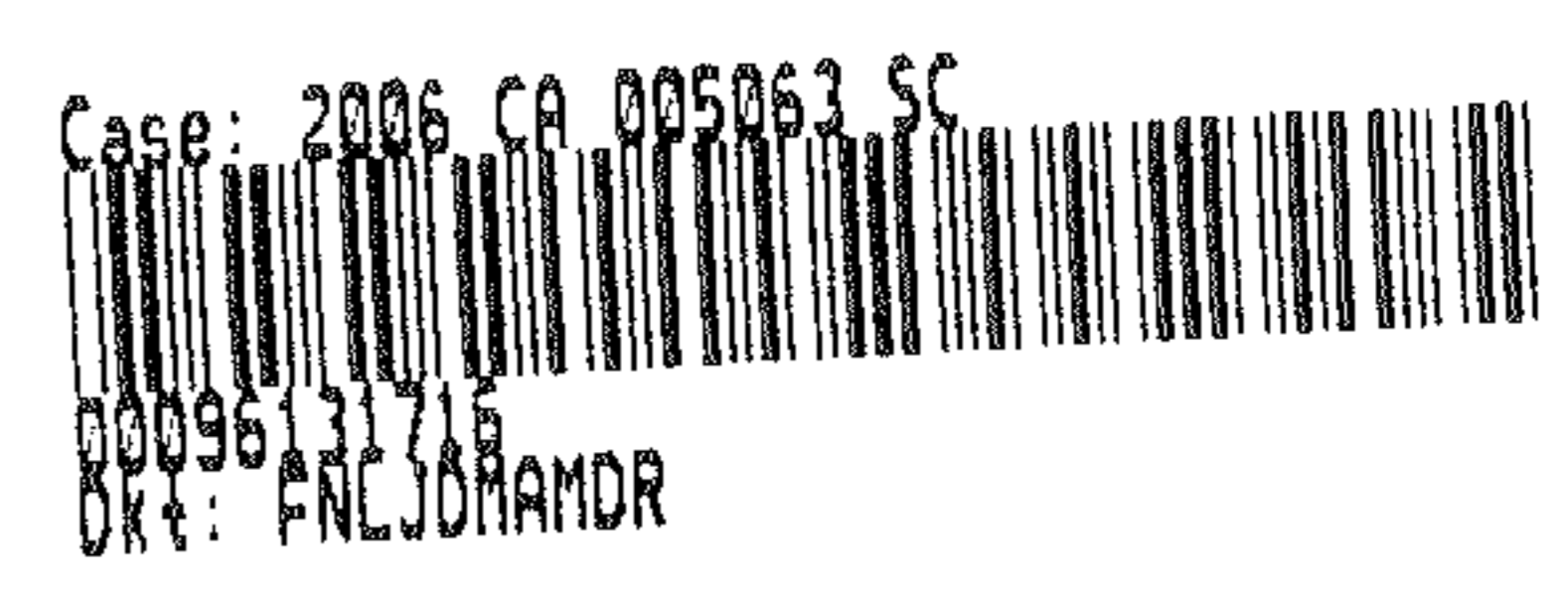
Ordered and Adjudged that the Plaintiff's Motion for Summary Judgment is denied. It is further
