5. Former Husband has incurred costs as a result of Former Wife's continued abuse of the discovery process for which Former Wife should be held answerable.

1. Deny Former Wife's requests in her Response to Former Husband's Ex-Parte Motion to Compel Discovery Pursuant To Administrative Order No. 5.011-9/92, Subsection B.

2. Awarding WILLIAM A. CABANA all costs pursuant to F.S. §86.011 and F.S. §57.041, this motion.

3. For such and other relief that may be proper.


