FORMER HUSBAND'S NOTICE TO THE COURT REGARDING  
FORMER WIFE'S MOTION FOR A PROTECTIVE ORDER

COMES NOW WILLIAM A. CABANA, pro se, respectfully affirms and warrants that he will not publish or disclose any personal information or place Former Wife at risk of identity theft by public disclosure of information not considered as being in the public domain.

In support he offers:

1. On August 18, 2005, Former Wife filed a previous similar claim for a protective order with her Emergency Motion For Injunctions, For Sanctions, and For Other Relief (D.E. 217).
2. On August 18, 2005, the court ruled to deny Former Wife relief for her Emergency Motion for Injunctions, For Sanctions, and For Other Relief (D.E. 218).
3. Prior to Former Wife's filing of the motion for injunctions, Former Husband had inadvertently posted some of Former Wife's financial documents on the [www.abolish-alimony.org](http://www.abolish-alimony.org) website. When he was advised of this by Former Wife's attorney prior to filing the motion, he immediately removed them from the website. At the hearing on

September 14, 2005, he assured the Honorable Martin Colin that they had been removed and only those documents that were public records on file with the clerk would ever appear on the website.

4. On September 6, 2005, Former Husband filed his Motion to Deny Injunctions, For Sanctions, and For Other Relief (D.E. 228) wherein he demonstrated that Former Wife allegations and concerns were groundless and without merit. The Honorable Martin Colin adjudicated the motion at a hearing on September 14, 2005 and no further action was taken against Former Husband.

5. Former Wife has not challenged any of the additional website postings since the hearing of September 14, 2005. She now offers no support or evidence for her allegations or concerns expressed in her ex-parte letter to the Honorable Elizabeth Maass (D.E. 479) or has shown where Former Husband has acted in bad faith regarding postings.

6. Former Wife has not shown that Former Husband has violated any law regarding the website's content or has provided evidence supporting a claim that immediate and irreparable injury, loss, or damage will result to the movant.


7. Former Wife's ex-parte letter to the Honorable Elizabeth Maass (D.E. 479) indicates that the payment of \$250 was not posted on January 1, 2009. A payment receipt from the FLSDU's online agent (D.E. 474) shows payment on January 2, 2009. Former Wife ignores the fact that January 1<sup>st</sup> (New Year's Day) is a legal holiday. Former Husband's only responsibility is to make the court-ordered payments to the FLSDU and not to Former Wife. After payment is made to the SDU, his obligation ends.

8. Former Husband assures this court that no postings will ever occur that will display any of Former Wife's records other than those of the public records on file with

the clerk and thereby not subject her to identity theft.

WHEREFORE WILLIAM A. CABANA, *pro se*, prays that the Court take notice of these facts, deny Former Wife's Motion for Protective Order and compel her to comply with the Order Granting Former Husband's Ex-Parte Motion to Compel Discovery Pursuant to Administrative Order 5.202 issued January 5, 2009 (D.E. 472).


