The Court further finds that the Former Husband has the present ability to satisfy the purge requirements herein and that the source of same is the various bank and brokerage accounts of the Former Husband that have balances in excess of the purge amount set forth herein. It is therefore

ORDERED THAT ALL AND SINGULAR, THE SHERIFFS OF THE STATE OF FLORIDA, are directed to take into custody WILLIAM A. CABANA and commit him to the Palm Beach County Jail for an indefinite period of time of his arrest; provided, however, he may purge himself of contempt and be released from custody by paying the sum of Seven Thousand Five Hundred (\$7,500.00) Dollars, together with all costs and Sheriffs fees, to the Sheriff of Palm Beach County, one of his deputies, who shall in turn shall pay said sum over to the Clerk of Court for disbursement to Sharon A. Mayo, 220 Almeria Rd., West Palm Beach, FL 33405.
