## ORDER OF DISQUALIFICATION

THIS CAUSE was presented before Commissioner/General Master <u>Judette N. Fanelli</u>, sitting as a General Master pursuant to Rule 12.490, Florida Family Law Rules of Procedure, on April 7, 2004, for hearing upon Former Wife's Motion for Contempt. The Former Wife was present and was represented by counsel. The Former Husband was present and was not represented by counsel. Based upon the circumstances presented, and upon review of the court file, the Court finds as follows::

1. Upon review of the court file, it was determined that the Department of Revenue previously enforced the support and alimony obligations in this cause. The Commissioner/General Master was the attorney of record for the Department of Revenue in the enforcement actions instituted by the Department of Revenue. Pursuant to Canon 3 of the Code of Judicial Conduct, prior to the commencement of the hearing, the Commissioner/General Master advised both parties of this fact. Both parties were further advised of their right to request another Commissioner/General Master conduct the hearing. Both parties acknowledged the basis for disqualification, waived the disqualification and requested the Commissioner/General Master proceed with the hearing.

Due to procedural and jurisdictional issues, it became necessary to continue the hearing upon Former Wife's Motion for Contempt.
