ORDER VACATING ORDERS ON
FLORENCE CABANA'S MOTION TO OBJECT TO NOTICE OF PRODUCTION (D.E. 130),
FORMER WIFE'S MOTION TO STRIKE FORMER HUSBAND'S MOTION
TO DENY CONTEMPT AND TO TERMINATE ALIMONY (D.E.131),
FORMER HUSBAND'S MOTION TO OBJECT TO NOTICE OF PRODUCTION (D.E. 132),
FORMER HUSBAND'S MOTION TO OBJECT TO REQUEST TO PRODUCE (D.E. 133),
AND
FORMER WIFE'S MOTION TO COMPEL FINANCIAL AFFIDAVIT (D.E. 134)

THIS CAUSE came before the Court upon Former Wife's Motion to Correct Clerical Error relating to the Order on Former Wife's Motion to Strike Former Husband's Motion To Deny Contempt and to Terminate Alimony (D.E.135). The Court, being advised that Former Husband had attempted and intended to telephonically attend hearing of all other motions herein referred to, all of which were entered by this Court on May 24, 2005, that the said motions were transferred to Division FC in the absence of the presiding Judge in Division FD due to attendance at a judicial conference, and finding that, in the interest of justice, the Former Husband should be given an opportunity to present substantive arguments on the Motion,

ORDERS AND ADJUDGES as follows:

1. This Court's Orders on
 - (a) Florence Cabana's Motion to Object to Notice of Production (D.E. 130)
 - (b) Former Wife's Motion to Strike Former Husband's Motion To Deny Contempt and to Terminate Alimony (D.E. 131),
 - (c) Former Husband's Motion to Object to Notice of Production (D.E. 132)

- (d) Former Husband's Motion to Object to Request to Produce (D.E. 133), and
- (e) Former Wife's Motion to Compel Financial Affidavit (D.E. 134)

are hereby vacated and set aside.

- 2. All motions shall be re-set for hearing in Division FD.
- 3. This Court retains jurisdiction to enter such other and further orders as may be

proper.
