

**FORMER WIFE'S MOTION FOR SANCTIONS**

**COMES NOW** the Former Wife, SHARON ANN MAYO, by and through her undersigned counsel, files her Motion for Sanctions, and in support thereof states as follows:

1. On September 16, 2005, the Former Wife served the Former Husband, WILLIAM A. CABANA, with Interrogatories for Modification Proceedings and her Second Request to Produce.

2. The Former Husband, WILLIAM A. CABANA, was required answer the Interrogatories for Modification Proceedings and to produce documents responsive to the Second Request to Produce within 35 days of the date of service.

3. The deadline for the Former Husband to answer the Interrogatories for Modification Proceedings and respond to the Second Request to Produce was October 21, 2005.

4. Former Husband failed to respond to the discovery requests, on November 21, 2005 this Honorable Court entered an Order compelling Former Husband to answer the subject interrogatories and respond to the Second Request to Produce within 10 days, that

being December 1, 2005.

5. Former Husband has failed to comply with the November 21, 2005, Court Order.

6. Former Wife requires the subject production to prepare for trial in this matter, which is specially set on January 5, 2006.

7. The Former Wife has incurred additional attorney's fees and costs as a result of Former Husband's non-compliance, for which Former Husband should be held answerable.

**WHEREFORE** Former Wife prays that this Court enter its Order sanctioning Former Husband for his failure to provide discovery and comply with prior Court Order, that this Court strike Former Husband's pleadings, for an award of attorney's fees and costs; for such other and further relief as may be proper.
