

TEMPORARY INJUNCTION

THIS CAUSE came on to be heard before the Court on the Former Wife's Emergency Motion for Injunction, for Sanctions, and for Other Relief. The Court has considered the specific facts shown by the Verified Motion and has determined that immediate and irreparable injury, loss or damage will result to the Former Wife before the Former Husband can be heard in opposition. This Court is satisfied with Former Wife's attorney's certification regarding lack of effort to give notice of the application to this Court for the entry of this temporary injunction. Furthermore, this Court is satisfied that Former Wife has met the requirements of Rule 1.610, Florida Rules of Civil Procedures, for the entry of a temporary injunction. Accordingly, it is the finding of this Court as follows:

- a. That this Temporary Injunction was granted without notice to the adverse party;
- b. That this Temporary Injunction was entered on this \_\_\_\_\_ day of August, 2005 at \_\_\_\_\_ o'clock a.m./p.m.;

- c. That it appears from the facts of record that entry of this Temporary Injunction will serve to prevent further harm to the Former Wife which, were the order not entered, would constitute further immediate and irreparable injury;

Accordingly, it is therefore

**ORDERS AND ADJUDGES** as follows:

1. The Emergency Motion for Injunction, for Sanctions, and for Other Relief filed in this cause by Former Wife, Sharon Ann Mayo, is granted.
2. That a copy of this order shall be delivered to the Former Husband by telefax (941/480-1395) and by U.S. Mail.
3. That in accordance with the requirements of Rule 1.610 this Court has determined that Former Wife should not required to post any bond.
4. That in accordance with the requirements Rule 1.610 this Temporary Injunction shall be binding on the Former Husband, William A. Cabana and on those persons in active concert or participation with him.
5. As described in reasonable detail, the act or acts restrained by this Temporary Injunction are as follows:
  - a. The Former Husband, William A. Cabana, is affirmatively ordered to immediately close the website entitled "Abolish-Alimony.org" and remove all documents published thereon;
  - b. The Former Husband, William A. Cabana is restrained and enjoined from further publication of any documents or information whatsoever

identifying Former Wife, Sharon Ann Mayo, her address, her social security number, her bank accounts, her credit card accounts, or any other items containing financial information regarding the Former Wife.

- c. The Former Husband, William A. Cabana, is ordered to return to Cathy L. Kamber, Esq., at 1675 Palm Beach Lakes Blvd., Suite 700, West Palm Beach, FL 33401, within 24 hours from the date of this order, any and all documents whatsoever in Former Husband's possession or control containing any financial information regarding the Former Wife, Sharon Ann Mayo, or any members of her family.
- d. Former Husband, William A. Cabana, shall, within 24 hours from the date and time of this order, furnish to Cathy L. Kamber, Esq., at 1675 Palm Beach Lakes Blvd., Suite 700, West Palm Beach, FL 33401, the name, address, telephone number, telefax number of any provider servicing any website, owned, operated, controlled by Former Husband or on which Former Husband has posted any information.
- e. Within 24 hours from the date of this order, Former Husband, William A. Cabana, shall furnish to Cathy L. Kamber, Esq., at 1675 Palm Beach Lakes Blvd., Suite 700, West Palm Beach, FL 33401, any and all documents whatsoever evidencing the names, address or other information whatsoever regarding any individuals, groups, corporations

or otherwise who have contacted Former Husband in any respect in response to the Abolish-Alimony.org website.

- f. Within 24 hours from the date of this order, Former Husband, William A. Cabana, shall furnish to Cathy L. Kamber, Esq., at 1675 Palm Beach Lakes Blvd., Suite 700, West Palm Beach, FL 33401, any and all information in Former Husband's care, custody and control concerning any individuals, groups, corporations or otherwise who have accessed the Abolish-Alimony.org website.

6. The Temporary Injunction shall remain in effect until further order of this Court.

7. All parties shall appear before the Court on August \_\_\_\_\_, 2005 at \_\_\_\_\_

a.m./p.m.

8. This Court specifically retains jurisdiction to award Former Wife, Sharon Ann Mayo, all reasonably incurred attorney's fees and costs.
