FORMER WIFE'S MOTION FOR CONTEMPT

COMES NOW the Former Wife, SHARON ANN MAYO, by and through her undersigned counsel, files her Motion for Contempt, and in support thereof states as follows:

1. On July 5, 2005 this Honorable Court entered that certain Order on Former Wife's Motion for Attorney's Fees and Costs, wherein Former Husband was ordered to pay attorney's fees to your undersigned counsel in the amount of \$412.50 on or before August 4, 2005.
2. On August 19, 2005 this Honorable Court entered that Order on Former Husband's Motion in Opposition to Deposition Duces Tecum and Discovery and Motion for Protective Order, wherein Former Husband was ordered to pay attorney's fees to your undersigned counsel in the amount of \$450.00 on or before September 9, 2005.
3. On September 28, 2005 this Honorable Court entered that Order on Former Wife's Motion for Sanctions, wherein Former Husband was ordered to pay attorney's fees to your undersigned counsel in the amount of \$467.50 on or before November 1, 2005.

4. The Former Husband has failed to make any payments whatsoever pursuant to the said orders.

5. The Former Husband has the ability to comply with Orders of this Court, but has failed to do so.

6. The Former Husband's failure to pay and to comply with these Court Orders is willful, intentional, and contemptuous.

7. The Former Wife has incurred additional attorneys fees and costs in the making and prosecution of this motion, for all of which Former Husband should be held answerable.

WHEREFORE, Former Wife prays that this Honorable Court enter an Order adjudicating Former Husband in contempt, awarding to Former Wife her reasonably incurred attorney's fees and costs, and for such other and further relief as may be proper.
